Becket Athenaeum, Becket-Washington's Community Library, receives \$2264 grant to fund weekly story time for children ages 0-5.

The Becket Athenaeum, Becket-Washington's Community Library, has received a \$2264 grant from Berkshire Taconic Community Foundation to fund **iListen iRead iLearn**, an enhanced weekly story time for children ages 0-5 and their caregivers that will also introduce children to the latest technology as it relates to reading, storytelling and learning.

The Becket Athenaeum is the nonprofit community library that serves the residents of Becket, Washington and beyond in Berkshire County. It abides by a strong, community-centered focus and tradition of offering educational programs and resources to patrons of all ages. The Athenaeum is pleased that this new and improved program will extend its program offerings to its very youngest patrons.

The Berkshire Taconic grant will be used for story time staffing, supplies and to purchase an iPad and educational apps to be used in conjunction with the storytelling activities. This program will run the rest of the school year, this summer and into the fall of 2014.

Becket Athenaeum Trustee, Aaron Beatty noted, "This program represents a natural and organic expansion of the Athenaeum's programs to a younger demographic. Many young children in our community face socioeconomic conditions that make the latest technology or educational resources unavailable. This project would help to bridge that gap. We are very grateful to Berkshire Taconic Community Foundation for their support in helping to make this program a reality."

Our Town has many attractive sites for the development of wind power. (A wind map has been posted on the website (http://www.washington-ma.com/.) Given this possibility, the Select Board, Planning Board and Finance Committee have jointly agreed that the development of a commercial-scale wind facility is not in the best interests of the Town. The Planning Board, working with Berkshire Regional Planning, has proposed a change to our by-laws to ban commercial wind power. There will be a Public Hearing April 8 at 7 pm at the Town Hall and any proposed change will be on the Annual Town Meeting (ATM) Warrant.

- We have also explored the adoption of MGL 131 39A ("Scenic Mountain Act") which regulates any activity "likely to have a significant adverse effect on watershed resources or natural scenic qualities" above certain elevations as a way of keeping our ridgelines clear of wind towers. Although this law is in force in many other towns in the Berkshires, its provisions are vague and do not seem to offer any significant change to the authority of the Conservation Commission which would be the rule-making and regulatory body. The Board does not intend to pursue this further.

Other Annual Town Meeting discussions:

- The Central Berkshire Regional School Committee approved a FY2015 budget which represents only a modest (2.06%) increase over FY2014. Thanks to our delegate and School Committee chair, Mike Case, for guiding these many weeks of difficult discussion.
- Purchase of a new large plow truck and/or a new smaller plow truck. Our loan on the Town Garage has only two years remaining. Our other indebtedness is the school bus, the police cruiser, the Becket-Washington School and several smaller CBRSD projects.
- Municipalities that have adopted Green Community status have experienced additional inspection costs and expensive construction delays; the Select Board does not recommend a re-vote on this issue and it will not be on the ATM Warrant.
- We are still considering the adoption of the Community Preservation Act. This would provide us with matching funds from the Commonwealth for preservation and improvement of historical sites and records, open space and recreation. These funds could, for example, be used to refurbish St Andrews, the Old Schoolhouse and/or the Old Town Hall. The funds could also be used to preserve our records, the Town Cemetery, the memorial at the Old Town Hall, to acquire private lots in North Lake for a Town recreational area or to improve our Town Park. Any project would have to be recommended by a separate committee and approved at Town Meeting. The funding would be from a 3% surcharge on our property tax with the first \$100,000 of assessed value exempt and a full exemption for low income residents. The average additional property tax is estimated at less than \$50 per household.

This winter continues its ill winds: we mourn the passing this March of two of Washington's citizens: Ron Adams and Peter Borgnis. They will be missed.
