The WASHINGTON CULTURAL COUNCIL SEEKS FUNDING PROPOSALS

Proposals for community-oriented arts, humanities, and science programs are accepted from September 1, 2012 to/and no later than October 15, 2012. Any application received after Oct 16, 2012 is not accepted.
The Washington Cultural Council has set an October 15th postmark deadline for organizations, schools and individuals to apply for grants that support cultural activities in the community. This deadline is mandated by the Massachusetts Cultural Council.

These grants can support a variety of artistic projects and activities: including exhibits, festivals, field trips, short-term artist residencies or performances in schools, workshops and lectures.

The **Washington Cultural Council** is part of a network of 329 Local Cultural Councils serving all 351 cities and towns in the Commonwealth. The LCC Program is the largest grassroots cultural funding network in the nation, supporting thousands of community-based projects in the arts, sciences and humanities every year. The state legislature provides an annual appropriation to the Massachusetts Cultural Council, a state agency, which then allocates funds to each community.

Reminder: everyone who has been appointed or elected to a Town position must be sworn in by Allison, our Town Clerk. Thanks to Jodi Hostetter, our Administrative Assistant, who has been working to communicate individually to our electees and appointees. Jodi is also working to get all of our records into electronic form and to get all our applications – jobs, permits, etc. - on the town website.

Over the past month:

Only one person came to Mapleview property for the walk-through so we are not hopeful for a useful bid. $_{\rm O}$

We are considering other options, including getting a grant for demolition of the property which could then be sold as a residential building lot. Anyone with a helpful suggestion – let us know!

We will be seeking bids to replace the windows and doors at the Town Hall. This will further update our 50 year old building and reduce our heating costs. Funding will require voter approval.

We are hoping to get some additional help from the Sheriff's Department to spruce up the exterior of the Town Hall.

The Eden Glen hydrological study has been completed. We will be preparing a grant application to restructure/rebuild the Depot Brook culvert/bridge/dam area.

We are still hopeful that Westfield Wild and Scenic will provide grant support for a new culvert on Cross Place Road.

Now that CSX has contracted with the USDA to control the beaver activity that blocks drainage on Upper Valley Road we are asking for restitution for the damage done so that the portions of Upper Valley that were submerged can be resealed and raised back up.

The Dalton Selectboard has expressed support for setting a weight limit for trucking on Blotz Road; we have not yet heard from Hinsdale.

State Senator Ben Downing has gotten \$750,000 added to the State's capital plan for the resurfacing of Washington Mountain Road in Washington, Dalton and Becket (McNerney Road). The funding depends on legislative approval and Governor Patrick's signature.

We are still applying for a separate Mass Infrastructure Grant to resurface Washington Mountain Road, and Becket is doing the same for McNerney Road. Dalton is not applying but is supportive of our effort. \circ

If either of these funding sources get approved we will finally have the complete length of Washington Mountain Road in good shape; if both are approved we should be able to do additional work on drainage and deeper reclamation and resurfacing.

The state has recently mandated that "sharps" – needles used for injection – can no longer go into the solid waste container but must be kept separate. What might have involved a costly new program for the Town turns out to be already taken care of by a pair of unsung heroes: Michelle Lampro, our Transfer Station Attendant and Sean Connors of Lovers Lane who already have a system up and running! Thanks to them both!

We finally got rain! Let's hope we don't go from drought to flood...Enjoy the tomatoes, the blueberries and the rest of the fresh food that Summer brings!
