Public Hearing Notice - Town of Washington

Town of Washington Board of Selectmen will hold a public hearing, on Monday, February 25, 2019 at 6:30pm at the Town Hall, 8 Summit Hill Road, Washington, MA 01223 to provide Eversource permission to install five hundred fifty feet of primary cable in an easterly direction from the intersection of Beach Road and Washington Mountain Road. The primary cable will run from a hexhole to a pad mount transformer for the transmission of electricity consisting of conduits located as shown upon the plan filed herewith and made a part hereof together with the necessary wires, cables, transformers switches protective devices and other appurtenances, and likewise the manhole and vault construction connected with said lines as indicated by said plan marked 6B821108.

Open Burn Season

State fire wardens determine each day whether conditions are safe for open burning. Weather and air quality can change rapidly, especially in the spring, and fire departments can rescind permits when that happens. Contact your local **fire department** to obtain an **open burning permit** in advance.

Contact the Fire Chief @413-623-2185 and leave your name, address you will be burning at and a contact phone number

According to Department of Environmental Protection regulation (310 CMR DEP 7.07), open burning must be done:

- Between 10:00 a.m. and 4:00 p.m. from January 15 to May 1
- At least 75 feet from all buildings
- As close as possible to the source of material being burned
- When air quality is acceptable for burning. Call the MassDEP Air Quality Hotline at (800) 882-1497 or visit the MassAir Online website at http://public.dep.
 state.ma.us/MassAir to find out if it is.

Only Certain Materials Can Be Burned

- Brush, cane, driftwood, and forestry debris from **other than** commercial or industrial land clearing operations.
- Agricultural materials such as fruit tree and bush prunings, raspberry stalks, and infected bee hives for disease control.
- Trees and brush resulting from agricultural land clearing.
- Fungus infected elm wood, if no other acceptable means of disposal is available

Burning Leaves and Other Materials Is Prohibited

- Brush, trees, cane and driftwood from commercial and/or industrial land clearing operations.
- Grass, hay, leaves, stumps, and tires.
- Construction material and debris.

*No hazardous materials/waste.

Piles should be away from utility lines

Large piles that will not readily burn or are of such size that they will not be totally out by 4:00 p.m. are prohibited. Complaints about smoke, soot or ash deposits occurring in neighboring property are grounds for revocation of a permit.

Hard to believe, but the construction season is coming up and we have a number of highway projects:

- After more than four years we expect to bid the construction of a new bridge over Coles Brook on Middlefield Road bridge this month. The Board had to request a doubling of our Small Bridge Grant to \$500,000 after the initial engineering inspection and approval of the existing abutments turned out to be faulty.
- We have submitted a grant application to MEMA for the replacement of the deep culvert on upper Frost Road. If we are awarded the money we will be able to cover the Town's portion of the cost with Chapter 90 money and put the work out to bid this spring.
- We are submitting two proposals to the Transportation Improvement Project list: refurbishment of Lovers Lane and, jointly with Becket and Middlefield, refurbishment of Middlefield Road/High Street. Once on the TIP list the Metropolitan Planning Organization has to vote to fund them. Good news: no Town funding is required. Bad news: it will be several years even if the MPO approves them.

Signs warning of mercury contamination in Ashley Lake have been posted. At our next Special or Annual Town Meeting the voters will be asked to approve funding for a gate to restrict access.

Our application to become a Green Community has been denied. Although our by-laws allow by-right installation of solar or wind power by residents, DOER insists that we have a by-law permitting utility-scale generation. We appealed to them that there is no transmission capacity in Town to support any such installation, but bureaucracy won out. We will present an appropriate by-law to the voters as soon as we have guidance from DOER.

Our citizens' committee to identify environmental hazards in Town and create a Hazard Mitigation Plan (HMP) has kicked off. We have grant funding to support this effort and we have contracted with Berkshire Regional Planning. Anyone interested in joining the effort please contact Jodi.

• Two other planning efforts are also in the early stages: 1) Creation of a Capital Plan and subsequent expansion of it into a broader plan for the Town's future; and 2) A plan for the Town Common's usage and preservation. If you have any interest in helping on either - or both! - of these, please let Jodi know.

Our Broadband installation is moving forward. We expect to sign an agreement with Wired West to operate and service our network. Construction of the network and our control hub will begin in the spring. Detailed costs and what monthly users' fees are expected should be available then.

Town Counsel has filed for summary judgment against Woody's. The Board has not yet been able to find enough money to demolish the structure.
