Our December Tracks is delayed in the mail. We hope everyone receives it soon!

Washington residence/property owners. Open burn season is coming and this year there is another option for getting a permit; 1) call (413)623-2185 and speak to me direct or leave a message (listen to the full message to be sure burning is being permitted for the day) when leaving message, include; name, address burning at, and contact phone number or 2) log onto www.bcburnpermits.com and follow the directions that are listed.

Weather conditions, current and predicted, are part of the determining factor for permitting. The MA DEP also makes a determination.

This past fall had red flag days and drought conditions and unless we receive significant precipitation those conditions will remain resulting in less permitable days.

Open burning must be done:

- Between 10:00 a.m. and 4:00 p.m. from January 15 to May 1
- At least 75 feet from all buildings
- As close as possible to the source of material being burned
- When air quality is acceptable for burning. Call the MassDEP Air Quality Hotline at (800) 882-1497 or visit $\underline{\text{MassAir Online}}$ to find out if it is.
- Fire must be attended by an adult until completely extinguished.
- Extinguishment materials/tools must be on site and available.
- No hazardous materials.
- Use common sense and be safe.
- Call 911 immediately if the fire gets out of control.

The sharp rise in COVID-19 infections continues throughout the Berkshires. The number of cases has quadrupled since the end of October and our positivity rate has tripled. Thirteen people died of the disease in the last half of November.

- The Governor has reinstated some of the restrictions that had been rolled back in the summer and fall. Please stay home, wash your hands, wear a mask and social distance if you must go out. Stay safe.
- The Governor has also announced expanded free testing in the County.
- On the bright side we expect that effective vaccines will be distributed starting this month. The first Massachusetts recipients will be health care workers, emergency responders and those in long-term care. Next are those at high risk, seniors, essential workers and small children starting in February. The current projection is for the general public to get the vaccine starting in April.
- The bottom line: the best case, assuming that there are ample supplies of the vaccine, that it is as effective as advertised and that the distribution goes according to plan is that we will be back to some kind of normality by late spring or early summer. Normality means that most of the population has gotten both shots of the vaccine and the infection rate approaches zero.
- We have been living with this for nine months and need to keep doing our part until this deadly virus is contained.

If you have not yet done so, please have everyone in your household fill out and return the survey included in last month's TRACKS. Extra copies are available at the Town Hall, the Transfer Station and on our website.

• The more responses we have the better our plans for the future of the Town will be. Thank you!

We have been awarded a \$69,000 grant to install a dedicated server and back-up system for the Town Hall. Thanks to John Les for helping put the proposal together.

The Commonwealth's Auditor has recommended that the PILOT program be fully funded and returned to a more equitable valuation system. If implemented the Town would receive additional funding for our state-owned lands.

Replacement of the Middlefield Road bridge over Coles Brook has begun.

We should hear about our ADA grant to improve access at the Town Hall this month..

A Court date has been set to determine if a Receiver will be appointed for Bucksteep. If appointed the Receiver will repair the property's water and septic systems. The costs will be billed to the owners or the property auctioned off if they do not pay.

We hope everyone had a safe and happy Holiday season. With vaccinations starting we now have some expectation that by mid-2021 we can return to our pre-COVID lives. Please keep safe until then. Now is not the time to relax our vigilance.


2021 Dog Licenses Available
