To our fellow Washington residents:

Between the Patriots' Day holiday and the lack of a quorum on 4/11 and 4/25 the Select Board met only once in April. We apologize to any residents who were inconvenienced.

The Board plans to appoint a Building Maintenance Coordinator. A job description for the position, which carries an annual salary of \$500, can be found on the Town's website. This appointment, like other appointments to the Town's various boards, committees and councils will be made in June, so anyone who is interested please let Jan Nelson (our Administrative Assistant while Jodie Hostetter is on maternity leave) know. Jodie and Jan have made this a seamless transition – thanks to both!

Due to increased concern that non-residents have been using our Transfer Station, stickers to identify residents are being printed. Once they are available they will be handed out at the Transfer Station by Michelle Lampro. The stickers are free and will also be available at the Town Hall.

In all likelihood Head Start will be moving to the Becket-Washington School. Among other implications, this will free up considerable space in the Town Hall. The Select Board, Finance Committee and the Planning Board will be considering the overall use of space in the coming months. If anyone has any ideas or concerns, please let us know.

Some updates:

- After the re-bid of the new boiler for the Town Hall we have received a quote that was slightly lower than the first. The boiler itself and a maintenance contract will be paid for by a Federal energy grant while a new on-demand hot water heater will be paid from the building maintenance budget. Energy usage at the Town Hall should be significantly reduced.
- Specifications for the insulation and re-siding of the Town Hall are being prepared by Berkshire Regional Planning. This work is also being funded by a Federal energy grant, and should also have a positive effect on energy usage.

We hope to see as many of you as possible at our Annual Town Meeting (7 pm Saturday May 14 at the Town Hall). Even more importantly, we hope each and every one of our voters exercises his or her most important civic duty during Town Elections on Saturday May 21. See you there.

TOWN OF WASHINGTON Preliminary Highlights of the Fiscal Year 2012 (FY12) Annual Town Warrant Submitted by Richard Spencer

Article 3: Elected officials have seen no salary increase in three years. After careful consideration of increases in required duties, mostly due to state requirements, and a survey of salaries in towns similar to ours, the town has budgeted large increases for the Town Clerk and the Assessors.

Article 5: Most General Government budgets are set at the FY11 level or have slight increases. Notable increases, however, are for Tax Collector and Town Clerk Expenses. Also, after several years at the same rate, the town has budgeted a significant increase for the consulting assessor who has shouldered the brunt of the department's duties since his appointment and has not seen an increase in many years. A significant decrease is requested for Selectmen's expenses. FY11 included several expensive legal ads. Also, a significant decrease in short term interest is anticipated, due to the acceptance last year of the ability to issue preliminary real estate tax bills. This greatly reduced the town's cash flow problems. Several costly projects are scheduled for the town park; but at press time that budget had not been finalized.

Articles 7 & 8: The capital budget for the Central Berkshire Regional School District is down 7.5%; and the much larger operating budget is up 4.5%. The increase in the assessment for operating expenses is solely due to the minimum contribution, which is set by a state formula not the school committee.

Articles 9 &10: We expect three vocational education students in FY12, two at Taconic High School and one at McCann Technical School. Due to the efforts last year of our primary bus driver, Victor Breen, negotiations with the town of Becket have led to significant decreases in the cost of vocational student transportation starting in FY 11.

Article 12: (Health & Safety) The Becket Fire Department has asked for a \$2000 increase this year. We have budgeted \$6000 for at least ten years. A small increase in Washington Police expenses is also anticipated.

Articles 13: (Community Services) The Becket Athenaeum has asked that we increase our support in FY 12. Over the past year, attendance at the library has increased 50% and circulation has increased nearly 40%. Washington accounts for about 15% of Athenaeum patrons.

Article 16: (Buildings, Grounds, Equipment) An increase is requested for some overdue repairs to the town hall, the school house on Washington Mountain, and the old town hall. The request for regular maintenance of town buildings is unchanged from FY11 at \$30,000. But, for FY12 the account has been split to include separate line items for the custodian (\$3100), a maintenance coordinator (\$500), and all other related expenses (\$26,400).

Article 17: Conservation Commission expenses are down after an expensive environmental notice of intent in FY11.

Articles 19 & 20: The first of these enables the town to join in the Western Massachusetts broadband initiative. Technically it establishes a municipal lighting plant under Massachusetts law. This article requires a paper ballot and approval by at least 2/3 of those present and must be passed twice. It was originally passed at the special town meeting of January 24, 2011. Article 22 seeks to appropriate \$1000 for the town to join WiredWest, the consortium that is working to bring high speed internet service to the area.

Article 22: This article seeks to transfer \$35,000 from the Stabilization Fund to reduce the FY 12 tax rate. As yet the state has not certified Washington's free cash. When that happens we hope to replenish the Stabilization Fund.

Overall the town's budget has decreased 1.2% from FY11; but we optimistically expect a 3.4% decrease in state aid (Governor's and House Ways & Means Committee budgets). If the Senate doesn't significantly reduce those aid figures, Washington's tax rate is expected to increase slightly.

After May 2nd, the full warrant will be posted on the bulletin board, will be on the Washington web site, <u>http://www.washington-ma.com/</u>, and will be available in hard copy at the town hall on Monday, 5/9, from 9:00 - 12:00 AM or from 7:00 – 9:00 PM.

The meeting is at 7:00 PM on May 14th.

Should Head Start stay or go? Submitted by Rose Borgnis

If you read last month's letter from the Selectmen you are already aware that Head Start was asked to explore the possibility of moving to Becket Washington School.

Comments that I have heard in regards to this range from; well we do need the space, to why would we want to lose the income along with a host of others in between. To determine the space needs at the Town Hall each committee, board, and office was given a short survey to fill out. Much to my surprise the majority of them came back stating that they do have adequate space for their needs. It was mentioned that cleaning out unneeded items and reorganizing the current space would go a long way in resolving any space needs of the foreseeable future. It was also mentioned that in order to expand the space currently offered to the Historical Commission the office used by the Head Start family advocate could be relocated to the stage area of the room currently being used by Head Start.

Head Start has been a very gracious tenant in the Town Hall for 18 years now. Knowing that they occupy the only room in our town hall large enough to hold all the residents who attend our annual town meeting, as well as on other occasions when we have asked to use the room, the Head Start teachers have willingly stayed late to tear down the classroom and come in early the next morning to get it all put back together. During the state and federal elections they cancel school so that they don't inconvenience anyone. Efforts have been made by the teachers to involve residents by inviting them to read stories to the children or help with an art or craft project. Having Head Start in the building has been beneficial as they have let us know when the heat was not working in the winter, when there was no water, when the fans for the heaters overheated and started to smoke, they sign for and receive packages and important documents for the town, and when the copier repair person or other service people need access to the building they don't mind letting them in. When told by the Building Inspector that code requires the playground to be fenced in they did not ask the Town to pay for any of the cost.

While the Select Board meets weekly and other boards or committees meet once a month, Head Start is there daily during the school year so they are more likely to notice and alert us to problems in the building which allows us to correct the problem before further damaged is caused. While the current amount paid (\$500.00 a month for 10 months) may not seem like much this is income to the Town that does not have to be raised by taxes. Whenever school is not in session families can bring our youngest residents to use the age appropriate playground equipment that Head Start has provided. Rather than asking them to leave I feel we should ask them for a 5–10 year lease with annual increases in the lease payment tied to the cost of living because what do we really gain by having head Start relocate?
