









As we noted last month we are wrestling with a number of issues related to the many home-based businesses in town. A new development has made this a much more immediate issue: Massachusetts requires – and has required for years – that personal property used in the conduct of business ("commercial personal property") be taxed at the Town's tax rate. If you have a home-based business that uses a tractor or a computer or a camera, etc., the value of that tractor or computer or camera is subject to taxation. Many of you have already gotten a letter from our Tax Assessor, Karen Avalle. Everyone with a business must fill out the form that accompanies Karen's letter so that the value of any property can be assessed. Please realize that this taxation is not new and that Karen has been directed to do this by MA DOR and that all details are confidential. Now for the good news:

- 1. There is no liability to individuals or the Town for prior years.
- 2. There will be a by-law on the Annual Town Meeting warrant on the 11th of May to exempt the first \$10,000 of "commercial personal property" from taxation.

In light of this the Planning Board is considering another business by-law that would:

- 1. Require all businesses in Town to register with the Town Clerk and pay a modest annual fee. There will be a fee exemption for very small businesses.
- 2. Impose a substantial fine on anyone not registering to assure equal treatment for everyone.

Our Assessors are also starting in-home assessments which have been overlooked in recent years. The law requires this to be done at least every nine years. You may be contacted for an appointment. Although you cannot be required to allow the Assessors on your property, a refusal risks having your property incorrectly valued and might mean that you would be denied abatement.

We have met with representatives of DOT and the rehabilitation of Washington Mountain Road is once again eligible for federal funds. However, the process is such that it will be four years or more before any work would start. Since this project should have been done 20 years ago the Board will continue to seek immediate funding through multiple channels. Our representatives are supporting us, but the more they hear from citizens who use the road, the better.

E2Sol, the company that had proposed to install solar panels on the roof of the Town Hall and sell us the power at a fixed rate, has rescinded their offer. The Board is considering other options for a "turnkey" deal to provide the Town buildings with renewable energy.

- We continue to pressure CSX for damages from the flooding of Upper Valley Road.
- We expect the auction date for Mapleview to be this month.
- Dalton plans to post a weight limit at the beginning of Kirchener Road at Washington Mountain Road; Hinsdale has not yet confirmed that it will post at Rte 8/Pittsfield Road. The Board is considering unilateral action if Hinsdale does not respond.


