FY17 Budget Summary

The total to raise and appropriate in the Town's upcoming FY17 budget is \$1,529,577. This is a net increase in the town's budget of \$54,725 (3.71%) over FY16, slightly less than last year's increase over the previous.

One of the most significant factors affecting next year's budget is a large rise in our medical insurance obligations due to both an increase in premiums and the addition of another participant (previously only two of our three eligible employees had elected to participate). There are increases in non-medical insurance as well, due both to rising premiums and coverage of new equipment.

Our CBRSD school assessment went up by much less this time than the previous year, but still a net increase. More significantly, our Vocational Ed. Tuition is doubling due to a second student electing to pursue vocational education next year.

The Finance Committee has recommended a moderate cost-of-living-allowance increase to wages (2.5%) pretty much across the board. Most town employees have not received any increase in the past few years.

On the flip side of the equation, next year's Debt Service has decreased by about one-third, which is significant, because we will have paid off our notes for both the Town Garage and the Police Cruiser.

Throughout the rest of the budget, most departments show some net increases. Expenses last year for improvements to historical buildings and the town park are non-recurring. This year we will be setting aside a similar amount to replace the glass & plastic recycling bin, the bottom of which has deteriorated beyond repair.

The State's municipal aid and local revenue estimates are not expected to increase by very much. So most of the FY17 budget increase will fall to the Tax Levy.

The Finance Committee's current preliminary estimate for the tax rate is \$14.17, an increase of 3.22% over last year. However, FY17 will be a tri-annual recertification year for assessments. If the overall valuation of the town shifts substantially as a result, then the jump in the nominal tax rate might appear much larger (or smaller).

Still, assuming that the relative distribution among taxpayers stays more or less the same and that new growth is rather modest, the current expectation is that the Average Single Family Home tax bill will increase by about \$100–120.

It is unfortunate that community participation in this gathering has dropped off dramatically in recent years leaving much to be done. Washington works because of the number and quality of our citizens who volunteer to serve on our various boards and committees. Flu season has come with a vengeance for all too many town residents. The strains of greatest concern are crossovers from birds. Anyone observing sick, dying or dead birds should report the incident to the MDFW (MA Division of Fisheries and Wildlife) at 508-389-6300 and/or the US Department of Agriculture at 413-253-2403. Residents who keep chickens should also take precautions to isolate their flocks from wild species.

Thanks to Carol Lew, Ed Bond and Ed Neumath for volunteering to work with Baltazar on the restoration of the Old Common and surroundings after its use as a staging area is complete. Baltazar has met with the group and is cooperating fully. The reconstruction of Washington Mountain Road is a large project and, however smoothly things go, residents should expect some glitches:

- At least one mailbox was knocked over. Baltazar was quite responsive to fixing it, but there are a number of mailboxes that the contractor will be moving as part of the work as well. Baltazar is working with the Becket PO to avoid any interruption in mail delivery.
- The DOT engineers in charge of the project met with a number of residents on April 13 and agreed to make improvements to what had been planned for drainage along the road.
- We have an ongoing dialog with the contractor regarding the steps they are taking to assure the safety of the Town's citizens. Please let the Board know of any specific concerns or incidents.

The Board authorized funds to determine if the existing abutments to the Middlefield Road bridge can support sufficient weight to be used for a replacement span. If so, the cost will be significantly lower than if we need new abutments. If we need new abutments the project may be delayed.

The Board sent a letter to the Governor demanding that the funds already allocated by the Broadband Act of 2008 – eight years ago for the construction of a broadband connection for all of our citizens be released immediately, either through MBI to WiredWest or directly to WiredWest. The Town's future economic viability depends on this project.

The replacement of the Frost Road/Eden Glen culvert is on track for completion this year. We are working to incorporate the restoration of the dam and recreational area into the project to get some economy of scale. Although the voters overwhelmingly supported the dam restoration, no funding has been appropriated; there will be an item on this year's Annual Town Meeting Warrant.

We hope to see all of you at our Annual Town Meeting on Wednesday May 11 at 7 pm and we hope all of you turn out to vote in our Annual Town elections on Saturday May 21 at the Town Hall between 12 and 4. Your participation is what makes government work for you.

How you can support WiredWest and the broadband project

At Annual Town Meeting last year, voters in Washington authorized borrowing our share of funding to build a regional fiber-optic broadband network to deliver high-speed internet service to our town. Work should have begun by now, but the Massachusetts Broadband Institute delayed the project. And the Baker Administration put it on "pause" while it reviews it.

Call it a delay, call it a pause, it's gone on for far too long. So WiredWest is taking action to get the project moving again. We've drafted a resolution for Select Boards to send to the Governor. Our Washington Selectmen passed their version of the resolution as well as a letter which was sent to the Governor, Administration officials, Senator Downing and Representative Pignatelli. Now it's your turn. A similar resolution will appear on the Annual Town Meeting warrant so that people in Washington can speak
