2016 Dog License Reminder

If you have not licensed your dog for the current license year (April 1, 2016 – March 31, 2017) please do so before October 31, 2016. After this date, there will be a \$10 late fee imposed for each license.

Licensing your dog is required by the Commonwealth of Massachusetts (MGL Chapter 140, Section 137) and a violation of this law is punishable by a fine of at least \$50 (MGL Chapter 140, Section 141).

Licensing your dog requires the following:

- A current rabies certificate.
- •If your dog is spayed or neutered; proof of this.
- Applicable fee: \$4.00 for spayed / neutered dogs and \$10.00 for unaltered dogs.

Please see the Town Clerk on Monday evenings from 7:00 – 9:00 PM with above mentioned items. You may also mail these to the Town Clerk, 8 Summit Hill Road, Washington, MA 01223 and license and tag will be mailed to you.

What is Early Voting?

Early voting allows <u>ANY</u> registered voter to cast their ballot prior to election day. Voting can take place by mail or in person.

Early voting will only be allowed in biennial state elections. The November 8, 2016 State Election is the first election where Massachusetts will allow early voting.

Early voting will begin 15 days prior to the election during the Town Clerk's regular business hours and during additional hours as determined by the Town Clerk and will end the Friday before the election.

For the November 8, 2016 election, the early voting schedule for the town of Washington will be as follows:

Monday 10/24/16 7:00 PM - 9:00 PM
Thursday 10/27/16 2:00 PM - 6:00 PM
Saturday 10/29/16 10:00 AM - 2:00 PM
Monday 10/31/16 7:00 PM - 9:00 PM
Wednesday 11/2/16 2:00 PM - 6:00 PM
Friday 11/4/16 7:00 AM - 11:00 AM

Early voting in the town of Washington will take place in the Town Clerk's office at the Town Hall, 8 Summit Hill Rd.

How will Early Voting Work?

In Person: Voters who are casting early ballots in person *do not* need to complete any prior paperwork. Once you arrive at the Town Clerk's office at the Town Hall during any of the above hours, the Town Clerk will check your name off the voter list and give you a ballot and an envelope to seal your completed ballot in. All early ballots will be kept by the Town Clerk until election day. Early ballots will be processed on election day in the same manner as absentee ballots.

By Mail: Voters who want to vote early by mail MUST first submit an application (or other written communication evidencing a desire for an early ballot). The deadline to apply for an early ballot is 12:00 PM on November 4, 2016. Upon receipt of the completed application, the town Clerk will mail you an early ballot with instructions for voting and returning it.

Ballot Counters Needed for the November 8, 2016 Election

I need people to help count ballots after the polls close on November 8, 2016. I currently have two sets of ballot counters and would like to have three more.

Here are the details:

- Arrive at the Town Hall for 7:00 PM. I will run a guick training on the counting/tally process for any new counters. Counting will start once the polls close at 8:00 PM.
- It could take anywhere from 1 3 hours to tally the ballots, depending on how many counters we have and how many total ballots we have.
- You will work in pairs with one person reading the ballots and one person marking the tally sheet.
- Once you have tallied all of your ballots and confirmed that your vote totals match the number of ballots you have for each race / ballot question, you will transfer your totals to the master ballot sheet.
- You will be paid for your time. The rate is \$10 per hour.

Initiative Petitions:

Question 1: If passed, this law would allow the state Gaming Commission to issue one additional category 2 license, which would permit operation of a gaming establishment with no table games and not more than 1,250 slot machines.

Question 2: If passed, this law would allow for up to 12 approvals each year of either new charter schools or expanded enrollments in existing schools, but to exceed 1% of the statewide public school enrollment.

Question 3: If passed, this law would prohibit any confinement of pigs, calves, and hens that prevents them from lying down, standing up, fully extending their limbs, or turning around freely.

Question 4: If passed, this law would allow persons 21 and older to possess, use and transfer marijuana and products containing marijuana concentrate (including edible products) and to cultivate marijuana, all in limited amounts, and would provide for the regulation and taxation of commercial sale of marijuana and marijuana products.

Further information on the initiative petitions will be available in the voter information booklets published by the state. These booklets will be available at the Town Hall once the state has printed and shipped them.





To our Washington neighbors:

Congratulations to our Assessors. For two years in a row they placed Washington among the earliest municipalities to have a certified tax rate, projected as a 2+/- % increase for next year.

On a sad note, our Assistant Tax Collector, Sue McGrath is leaving us to spend more time as tax collector in Savoy. Sue joined us in 2008 and has done a terrific job working down the unpaid tax backlog. We will miss her.

The Annual Sons & Daughters Reunion at the Old Town Hall on September 11 was a great success with reminiscences, good food and music. If you missed it, plan on being there next year!

The Berkshire County Education Task Force, comprised of educators and civic leaders including Selectman Mike Case, has been working for over a year to address three trends – falling student population, rising costs and lower government subsidies - that unless reversed mean degradation of our still excellent schools. The Task Force has now secured funding to develop plans for improved diversity, breadth and quality of education for all our children so they are fully prepared for college, career and a life here in the Berkshires. This will likely be achieved through consolidation of schools, improved use of technology, partnerships and regional agreements. The Task Force has pledged to respect and maintain the unique identity of each Berkshire community to ensure that our citizens remain fully connected to and engaged with our schools.

It appears that we now have a three-person committee for the design and financing of an expanded Veterans' Memorial. Anyone interested in being on the committee please contact Jodi.


Road & Bridge:

- Congratulations to Adam Southard for becoming our third DOT Road Scholar!
- Line painting and guard rails for Washington Mountain Road will be done this month.
- Blotz Road will also have lines painted in the near future. Thanks again to our road crew whose prep work saved the Town over \$10,000.
- The new Cross Place culvert is on schedule to be done this fall; there will be a public hearing on moving utility poles.
- DOR delayed the bid opening for the construction of the Frost Road culvert over Depot Brook until October 3; we do not
 expect any construction until spring.
 - The silver lining is that we should know whether our grant request for funding the removal of the Eden Glen dam has been approved long before that so that any work will be integrated with the culvert construction. We will hold a Town meeting to determine if our citizens will accept the money for removal or have the Town fund restoration of the dam.
- We are still waiting to hear whether funding for the Middlefield road bridge through either a MassWorks grant or the new small bridge program will be available.
- There will be three public hearings on October 17 regarding utility pole placement for Cross Place, Eden Glen and the Summit Hill bridge construction.

While the pole survey to prepare the installation of fiber optic cables appears on schedule for this fall, the Board still has serious questions regarding the financing.
