Early Voting

What is Early Voting?

Early voting allows **ANY** registered voter to cast their ballot prior to election day. Voting can take place by mail or in person.

Early voting is only be allowed in biennial state elections.

Early voting for the upcoming State Election will begin on Monday, October 22nd during the Town Clerk's regular business hours and during additional hours as determined by the Town Clerk and will end on Friday, November 2nd.

For the November 6, 2018 election, the early voting schedule for the town of Washington will be as follows:

Early voting in the town of Washington will take place in the Town Clerk's office at the Town Hall, 8 Summit Hill Rd.

How will Early Voting Work?

In Person: Voters who are casting early ballots in person do not need to complete any prior paperwork. Once you arrive at the Town Clerk's office at the Town Hall during any of the above hours, the Town Clerk will check your name off the voter list and give you a ballot and an envelope to seal your completed ballot in. All early ballots will be kept by the Town Clerk until election day. Early ballots will be processed on election day in the same manner as absentee ballots.

By Mail: Voters who want to vote early by mail **MUST** first submit an application (or other written communication evidencing a desire for an early ballot). The deadline to apply for an early ballot is 12:00 PM on November 2, 2018. Upon receipt of the completed application, the town Clerk will mail you an early ballot with instructions for voting and returning it.

State Election Date, Polling Location and Hours

The 2018 State Election is Tuesday, November 6, 2018. Voting will be at the Washington Town Hall, 8 Summit Hill Rd, Washington. The polls will be open from 7:00 AM until 8:00 PM.

Registering to Vote

If you are a Washington town resident 18 years or older, but have never registered to vote here, please see the Town Clerk on Monday evenings from 7:00 - 9:00 PM so you can register to vote. The deadline to register and be eligible to vote in the State Election is Wednesday, October 17, 2018. The Town Clerk does not normally have Wednesday office hours, but on this date the office will be open from 2:00 PM - 4:00 PM and 7:00 PM - 8:00 PM.

You can also mail a completed voter registration form <http://www.sec.state.ma.us/ele/elepdf/Voter-reg-mail-in.pdf> to the town hall. It must be postmarked by the October 17th deadline.

Absentee Voting

Registered voters can apply to vote by absentee ballot for one of three reasons.

- Voter will be absent from town on election day
- Voter has a physical disability
- Religious belief

In order to apply for an absentee ballot you must request one in writing. You can do this by email or postal mail. If done by postal mail (a signed letter or absentee ballot application) please allow for extra processing time.

Ballot Question 1	Proposed law to limit how many patients could be assigned to each registered nurse in Massachusetts hospitals and certain other health care facilities. The maximum number of patients per registered nurse would vary by type of unit and level of care.		
Ballot Question 2	Proposed law that would create a citizens commission to consider and recommend potential amendments to the United States Constitution to establish that corporations do not have the same Constitutional rights as human beings and that campaign contributions and expenditures may be regulated.		
Ballot Question 3	Referendum on existing law. This would add gender identity to the list of prohibited grounds for discrimination in places of public accommodation, resort, or amusement.

To our Washington neighbors:

October 2018

Our Assessors have once again been able to get early approval on our tax rate and, even better, the tax rate will not go up this year. A Washington candidate has applied for the open position.

- We are still looking for someone with clerical skills and experience to back up our Administrative Assistants Jodi Hostetter and Jan Nelson.
- Our Council on Aging will not be the same when Steve Deloye steps down later this year. Not only did he do a great job of organization but he was head chef for the monthly Pot Luck suppers. It's a tough act to follow but our seniors really need someone to step forward!

No word yet on our grant application to replace the Town Hall roof, but our application to become a Green Community is moving forward.

If the owner of Woody's has not provided proof of immediate demolition by October 15, the Town will proceed to do the work. It is important that the structure be torn down before winter sets in. Any expenditure by the Town will become a lien on the property.

The lack of clarity about the tragic shooting in October Mountain State Forest on August 20 is making it more difficult for the Board and Chief Miller to determine what additional security measures are needed. We'll keep you posted.

Highway:

- We should be able to bid the reconstruction of the Middlefield Road bridge over Coles Brook this month, but it is unclear whether the work can be completed this year.
- We have applied for an exemption to the FEMA rule that requires that we have a Disaster Mitigation Plan in order to apply for FEMA/MEMA funding for the deep culvert on upper Frost Road. We applied over a year ago for a planning grant.

Westfield Gas & Electric, who will design and construct our Broadband network, has been able to tap into a federal program called the Connect America Fund (CAF) which means that we will receive \$33,000 a year for the next ten years to construct and maintain the system! This means a significant reduction to the financial demands on the Town.

We met with Senator Hinds to solicit his help on three areas that skew our financial planning: PILOT funding, the high cost of bridge and culvert repair, and Voc-Ed transportation reimbursement. We will be working with him and his staff on all three.

- The Board will also contact Governor Baker directly regarding PILOT funding and policies and will work with both Rural Commonwealth and the Berkshire Selectmen's Association to get their support for PILOT reform.

Berkshire Regional Planning has a survey to help plan future transportation in the County. Please go to www.surveymonkey.com/r/berkshireplan2 and let them know what works for you. There will be an info session Wednesday October 17 at 5 in the Berkshire Athenaeum.

Wahconah Building Project Update



WBC and School Committee Unanimously Approve Building Project

On August 23rd the WBC and the CBRSD School Committee voted to submit a preferred schematic design to the MSBA as part of the next phase of the feasibility study. Last Spring DRA presented 13 designs that included renovation/addition and new construction options. After comparing multiple evaluation criteria a final new construction option was chosen. This design option will be submitted to the MSBA on September 12th for the next stage of state approval. The following were identified as strengths of the chosen design:

- Best meets the educational plan
- Best long term value (lowest cost of the new construction plans)
- Energy efficient, compact yet flexible floor plan
- Best use of the Wahconah campus and adds green space
- Secure single main entrance
- Driveway design that safely separates cars, buses, and pedestrians
- Short timeline with minimal disruption to the current school

The decision to submit a new construction option versus a renovation/addition option was based upon the following:

- Options did not fully meet the educational
- Long construction timelines (3 years) highly disruptive for students
- Need for temporary classrooms that are not reimbursed by the state
- Some small classrooms and an undersized gymnasium would remain
- Greater chance for unforeseen expenses and change orders
- Cost estimates were within 5% of new construction costs

Updated Timeline

Fall 2018

DRA and the school Building Committee will refine the building design and materials to build a budget

February 2019

The WBC will share the budget with the towns to determine the impact on tax rates

Spring 2019

Towns will vote on the building project

March 2020

If approved and funded by the voters construction would begin

September 2021

New Wahconah would open
