## The WASHINGTON CULTURAL COUNCIL SEEKS FUNDING PROPOSALS for the year 2015

Proposals for community-oriented arts, humanities, and science programs are accepted from September 1, 2014 to/and no later than October 15, 2014. Any application received after Oct 16, 2013 is not accepted. The Washington Cultural Council has set an October 15th postmark deadline for organizations, schools and individuals to apply for grants that support cultural activities in the community. This deadline is mandated by the Massachusetts Cultural Council.

#### Applicants must be Non Profit.

These grants can support a variety of artistic projects and activities: including exhibits, festivals, field trips, short-term artist residencies or performances in schools, workshops and lectures.

The Washington Cultural Council is part of a network of 329 Local Cultural Councils serving all 351 cities and towns in the Commonwealth. The LCC Program is the largest grassroots cultural funding network in the nation, supporting thousands of community-based projects in the arts, sciences and humanities every year. The state legislature provides an annual appropriation to the Massachusetts Cultural Council, a state agency, which then allocates funds to each community.

To our fellow Washington residents:

#### September 2014

Kinder-Morgan representatives - the company proposing a new natural gas pipeline through Massachusetts, presented and answered questions from the twenty residents who attended on August 14. As presently designed the pipeline would cross into Washington from Lenox west of Farnham Reservoir and run through Town for less than a mile before crossing into Pittsfield. Although no Washington residents or property owners would be affected, the pipeline is shown as crossing both Washington Mountain Road and Blotz/Kirchener in Dalton. The Board wants to stress several points:

- 1. History, economics and the law make the construction of this pipeline a near certainty, like it or not.
- 2. Nevertheless, several of our neighbor towns are strongly opposed to this pipeline and we the Board will be supportive of them.
- 3. The route may change and become more of an issue for us.

The K-M presentation is posted on the Town website. The Federal Energy Regulatory Commission which approves and regulates pipelines has a website: www.ferc.gov. The Board would like to hear more from our citizens on this issue. Please let us know.

We are still waiting for FEMA to decide whether we are getting grant funding to restructure the area around Eden Glen Dam to mitigate flooding and widen the road.

- The Board has heard conflicting opinions as to whether the dam should be removed to improve the flow of Depot Brook or retained and rehabilitated as a flood barrier and recreational pond. We want to hear more from our residents!
- We have issued a Request for Proposals for design studies of the culverts (bridges) on Lower Sargent, Lower Valley and Cross Place. We should be able to bring a cost proposal to our voters in October.

The PASER study of the Town's roads should be complete by the end of September. In addition to their current rating we can compare them to a 1998 BRPC rating study.

The Business Census has been completed with about 70% compliance. About one-sixth of our homeowners have one or more businesses and all but a few conform to our existing by-laws. Next steps include deciding whether to require no-fee registration of businesses and drafting an amendment to our by-laws for voter approval.

- The sale of Bucksteep has brought the need for clarification into sharp relief since the prior use of the property was non-conforming.
- The new owners of Bucksteep have said that they plan to contribute to the Town since, as a non-profit, they are not required to pay taxes.

We have asked the State Police for increased patrols and for truck weight stops.

Don't forget that two unique Washington events are coming up: The Hilltown Hoot on September 7 at the Town Park and the Sons & Daughters Reunion on the 14th at the Old Town Hall. See you all there!

Also, don't forget the State primary election on September 9. We are only as strong as our voter turnout.


Remember, WASHINGTON LOVES ITS SENIORS...
