MARCH 20, 2023, STM WARRANT ARTICLE & EXPLANATION

Article 3. To see if the Town will vote to affirm the decision of the Select Boards of Washington and Middlefield to readvertise the position of shared Town Administrator with an annual salary of up to eighty thousand dollars plus benefits and with an appointment by said boards for up to three years as provided for pursuant to Massachusetts General Laws Chapter 41, section 23A; or to take any other action in relation thereto.

EXPLANATION

A Yes vote affirms the decision of the Select Boards of Middlefield and Washington to readvertise the position of Town Administrator for a higher salary than originally offered. Although this vote is not required by law or regulation, both Boards believe it is important to keep town residents informed and have their approval before increasing.

With the assistance of Berkshire Regional Planning Commission, the position was advertised in the fall of 2022 with a maximum salary of \$60,000. The initial term was a one-year contract, due to the expiration of grant funding after the first year of employment. After two extensive rounds of advertising in 12 venues online, in newspapers of general circulation, and in trade publications, there were only five applicants. Two of the applicants dropped out before interviews; one opted not to have a second interview; two were offered the position, but declined thereafter.

After the final candidate dropped out, the Boards met to jointly review the situation. BRPC prepared a survey of Town Administrator salaries in 29 Western Massachusetts towns with populations less than 2000. With data primarily from 2021 and 2022, the survey revealed a range from just under \$60,000 to approximately \$90,000. The average salary was approximately \$70,000.

Given the extraordinary task of administering two towns simultaneously and the apparent dearth of qualified applicants at the former offer, and after considering the estimated tax rate impact of an increase, the Boards decided that offering a maximum salary of \$80,000 was the most appropriate way to attract qualified applicants. The Boards also decided that a three-year term of appointment would complement the higher salary as an inducement. The longer term does not present any additional financial risk to the communities since the position is still strictly subject to annual appropriation.

The tax rate analysis shows a difference of approximately 5¢ per thousand valuation by increasing the salary from \$60,000 to \$80,000 during the initial grant-subsidized year and 10¢ once the grant is phased out. Accordingly, the increase would add roughly another \$15 to the average single family tax bill during the first year, which would then become \$30 after the grant is expended.
